

Twenty-eight deaths had been reported in the region since the start of the pandemic. The health department on

According to the Illinois Department of Public Health, in Illinois there were 11,632 new individuals with COVID-19 identified on Nov. 16, bringing the confirmed total in the state to 585,248 individuals, with 10,779 deaths.

# Area projects included in Rebuild **Illinois funding announcement**

The Illinois Department of Transportation, IDOT, on Friday, Nov. 13, announced that \$112 million is being awarded to 31 downstate transit providers as part of the Rebuild Illinois capital program.

The grants are designed to help to expand and improve service, providing more transportation options and promoting an enhanced quality of life in communities throughout the state.

Projects include the purchase of new vehicles as well as the construction of new bus shelters, stations and maintenance facilities.

Projects in Union County and Pulaski County are among those which are planned.

Shawnee Mass Transit District has been apportioned \$2.724 million through the Rebuild Illinois program.

Funding will be used to purchase land, to design and build a new office building/depot with an attached maintenance garage in Union County.

Included will be a parking lot large enough to house 15 various size buses and minivans with employee/customer parking equipped with handicap accessible parking spaces.

Also included will be funds to design and build a new administration facility in Pulaski County.

Rebuild Illinois identifies a total of \$4.5 billion, including \$3 billion in bonding and \$1.5 billion in new pay-as-you-go funding, to invest in transit throughout the state.

State officials said the Nov. 13 announcement was the first installment of \$355 million being distributed via grants in three cycles to transit providers outside the Chicago area.

The remaining funds will be distributed in two more distributions, with the next call for proposals in 2021 and 2023.

Passed in 2019, Rebuild Illinois is investing a total of \$33.2 billion over six vears into the state's aging transportation system, creating jobs and promoting economic growth.

Work on the county's Fiscal Year 2021 budget was discussed at Friday morning's meeting.

The county's new fiscal year begins on Dec. 1 and continues through Nov. 30, 2021.

County administrator Angie Johnson reported that she has been meeting with officeholders and department heads to finalize the details of a new budget.

Johnson said that due to the pandemic, uncertainty surrounds revenue which the county can anticipate.

"It's very hard to predict," Johnson said. She said every effort is being made to take a conservative approach to the budget situation

The church plans to deliver meals to those who request them on Thanksgiving Day, between 11 a.m. and noon. Thanksgiving Day is Nov. 26.





# **IHSA plans to discuss** winter sports at board meeting on Nov. 19

Association, IHSA, Board of Directors held a virtual update session on Nov. 11 to review recent developments related to the IHSA basketball season ahead of the board's regularly scheduled meeting on Nov. 19.

IHSA reported on its website that the board announced it was formally inviting representatives from Gov. JB Pritzker's office and the Illinois Department of Public Health, IDPH, to attend the IHSA board meeting on Nov. 19.

Additionally, the IHSA said it will also seek representation at the meeting from the Illinois Principals Association. IPA. the Illinois Association of School Administrators. IASA, the Illinois State Board of Education, ISBE, and a coalition of nearly 200 school superintendents who recently contacted the governor regarding school sports during the 2020-2021 school year.

"The Board hopes to create a dialogue and build a more collaborative relationship with all the entities involved with developing sports policy in our state as everyone tries to navigate the myriad issues caused by the pandemic," IHSA executive director Craig Anderson said in a statement which was posted on the association's website.

"The Board's decision to move forward with the IHSA basketball season was not meant to be adversarial. It was rooted in a desire to receive more direct communication and data from our state partners.

They hope all the groups will see the mutual benefit of increased discourse and

The Illinois High School be represented at the meeting on November 19."

> The board also announced that schools which planned to begin basketball practice on Nov. 16 should adhere to the Level 1 mitigations from the IDPH All Sports Policy until at least Nov. 19.

> The board cited rising COVID-19 cases in the state and a recent membership survey for this recommendation.

The board plans to provide more direction on basketball practice and games following the meeting on Nov. 19.

The board revealed that among the 546 schools who responded to the survey (IHSA has 813 member schools), nearly 300 IHSA schools did not plan to start basketball on Nov. 16, and another 212 schools remained unsure of their status.

"The Board recognizes the difficult decisions they have placed on member schools regarding basketball," said Anderson.

"With a limited number of schools set to begin their season on November 16, they believe it is prudent to adhere to IDPH guidance as they work with state officials to gain greater clarity on the metrics and mitigations required to conduct certain high school sports throughout the remainder of the 2020-21 school year."

Anna-Jonesboro Community High School boys' basketball head coach Mark Chamness hopes to know more about the future of the season after the meeting which is scheduled today.

Chamness said he thinks the season more than likely will be postponed until January because of the ongoing pandemic.

#### SIU men's basketball pauses First firearm deer team activities after positive **COVID-19 test results**

University Carbondale Dec. 2 at Southeast Missoumen's basketball program announced Nov. 12 that it had paused team activities due to positive COVID-19 test results.

The announcement was made by the team's head coach, Bryan Mullins. The announcement was posted online at siu.salukis.com.

As a result of the pause, SIU will not participate in the Wade Houston Tipoff Classic in Louisville, Ky., from Nov. 25-29, as previously scheduled.

"We have diligently followed the safety protocols established by our administration and local health officials, but as we've seen throughout the country, COVID cases can and will arise," Mullins said.

"We will resume preparation for the season as soon as our medical professionals deem it is safe to do."

Treat every firearm as if it is loaded, and never assume a firearm is unloaded. Always point a firearm in a safe direction.

Be sure of the target, and make sure there are no other hunters, homes, buildings, vehicles or other animals beyond the target.

Keep their finger out of the trigger guard and off the trigger until they are ready to shoot.

Other safety considerations include ensuring heating sources are properly ventilated in hunting cabins and boats, wearing appropriate, high visibility clothing while hunting (including blaze orange or blaze pink when required), and being familiar with the area being hunted.

The Illinois archery deer season opened Oct. 1 and continues through Jan. 17, 2021.

Archery deer season is closed during the firearm deer weekends except in those counties where firearm deer hunting is not permitted.

IDNR also has announced changes to 2020-2021 deer hunting procedures at state sites.

The changes, health and safety protocols implemented in response to the ongoing coronavirus pandemic, will provide greater protection to both the hunting public and site staff during the season.

IDNR said that hunters should follow all public health guidelines issued by the Illinois Department of Public Health, including wearing masks when social distancing cannot be achieved and refraining from congregating in parking lot areas.

Through responsible actions, hunters can help ensure that site hunting programs continue to offer Illinoisans healthy outdoor recreation opportunities,



# Public health alert issued in Jackson **County as COVID-19 cases surge**

The Jackson County Health Department reported on Nov. 12 it had been notified in the previous 24 hours that 87 Jackson County residents were confirmed to have contracted COVID-19.

As of Nov. 12, 395 active cases were being managed, which the health department said was a record high.

The health department reported that as of that date, there had been 2,077 confirmed cases in the county, including 28 related deaths.

Seventeen individuals were released from isolation, in accordance with CDC guidelines, bringing the total released to 1,654 individuals.

The Jackson County Health Department on Nov. 12 also issued a public health alert.

The health department said in a news release that the alert was issued to raise awareness and to elicit public action to stem the tide of rising COVID-19 infections.

# The art of carving the turkey

There was a time when, a gentleman's education was not complete until he had mastered the art of carving.

Those days are long since forgotten. By 1928, Emily Post had dropped the section on carving from her book on etiquette all together.

Many a noble bird has been hacked to shreds at the hands of unskilled knife-wielding relatives and friends, as horrified cooks looked on.

This year, avoid the public carnage. Learn the simple art of carving like a pro.

Whether the bird is carved in the kitchen or at the dining room table, it simply must be done before anyone can eat. And it's not that difficult.

Tools: Meat fork with long tines, sharpened carving knife or chef's knife, small cutting board on the side and a kitchen towel or napkin.

Allow the turkey to rest 20 minutes after cooking. This lets juices saturate the bird evenly again for better slicing. Remember that you must cut the bird apart at the

joint, hacking though the bone is not an option.

With an air of confidence, start with the dark meat. Secure the turkey at the breastbone with a carving fork or better yet, use a folded napkin.

Cut through the skin between the leg and body. Press the leg downward until it is lying flat against the platter. Now you can see the hip joint. Cut through the joint and remove the leg and thigh to a cutting board.

Cut the thigh and drumstick apart at the joint. Remove the skin and slice around both sides of the thighbone, removing the meat. Leave the drumstick whole. Repeat on the other side.

For the breast: Hold the turkey with a large fork at the breastbone. Slice about 2 inches down one side of the breastbone, gently separating the meat from the bone. Now make a horizontal slice across the grain of the meat. Remove the entire section of breast meat to a cutting board. Holding with a fork, cut into slices. Place slices on platter. Repeat pro-

# Storing leftovers

Plan ahead, clean out the refrigerator and make room for leftovers several days before the holiday feast.

Leftovers should be stored in the refrigerator within 2 hours after cooking is completed.

Why just 2 hours? Because bacteria that cause food poisoning can multiply to undesirable levels on perishable foods left at room temperature for longer than that.

Large quantities should be divided into smaller portions and stored in several shallow containers. Food in small amounts will chill faster keeping it safer and fresher.

# Hosting Thanksgiving during the pandemic

Much like the holidays that preceded it in 2020, Thanksgiving figures to be different this year. An ongoing pandemic has changed the way much of the world lives their lives, including how holidays are celebrated.

As the novel coronavirus COVID-19 spread across the globe beginning in the winter of 2019-20, the World Health Organization recommended a host of behaviors designed to prevent the spread of the virus and protect those who are most vulnerable to it. The Centers for Disease Control and Prevention also noted the importance of keeping distance from others, especially for those who are most likely to get seriously ill if they're exposed to COVID-19, such as the elderly and people with underlying medical conditions.

The WHO and the CDC continue to recommend social distancing, which means Thanksgiving in 2020 will be unlike any other. Families must make their own decisions about getting together this holiday season, but hosts who intend to welcome guests into their homes this Thanksgiving can take certain steps to keep everyone as safe as possible.

• Scale back the guest list. Families accustomed to large Thanksgiving gatherings can scale the festivities back this year in an effort to keep everyone safe. Consider hosting a meal for immediate family members only, as the Environmental Protection Agency notes that COVID-19 may spread more easily in indoor environments via airborne particles. Extended family members can visit

outside. If the weather permits, consider eating Thanksgiving dinner outside this year. Doing so may limit everyone's exposure to the respiratory droplets that researchers say can spread the virus when inhaled. If necessary, serve the meal earlier than you normally would so everyone can eat in midday when it's still warm outside. Hosts also can consider serving something more convenient than turkey, which takes a long time to cook, and limiting side dishes to one or two items.

• Assign seats. If the meal will be served indoors, then hosts can assign seats to protect those most vulnerable to serious illness from COVID-19. Instead of cramming everyone in at one table, set up temporary tables and have guests sit in every other seat rather than next to one another. Isolate the vulnerable as much as possible while still ensuring they can engage in conversation.

• Discourage guests from attending if they feel sick. A list of COVID-19 symptoms can be found at www.cdc.gov. In the days prior to Thanksgiving, hosts can share that list with guests via email or social media and discourage guests who are feeling ill on or around the holiday from attending the festivities. If necessary, make a to-go plate for ill relatives and drop it off at their homes so they can still enjoy Thanksgiving dinner.

 Stock up on hand soap and hand sanitizer.
 Hosts should make sure hand soap and sanitizer is readily available throughout their homes. When guests arrive, make sure everyone washes their hands immediately, and encourage guests to continue doing

• Consider eating Thanksgiving dinner so throughout the day. Thanksgiving will be different in 2020. Hosts need to adjust their normal Thanksgiving routines to ensure the safety of their guests.

# **Traditional Roast Turkey (unstuffed)**

1. Preheat oven to 325°F. Check the wrapper to see how much the turkey weighs and determine approximate cooking time. Remove the giblet bag and the neck from the turkey cavity. No need to wash the turkey (see Wash Hands: Not the Turkey), pat skin dry with paper towels.

2. Place turkey breast side up on a rack in a shallow (about 2 inches deep) roasting pan. Insert meat thermometer in thigh. Add 1/2 cup water to the bottom of pan, if desired.

3. Cover turkey loosely with a tent of heavy-duty aluminum foil. Roast the turkey until temperature in the innermost part of the thigh reaches 165°F as measured with a food thermometer. Check the wing and the thickest part of the breast. You may choose to cook the turkey to higher temperatures. Cooking time will vary. For example, a 20 pound turkey will take 4 1/4 to 5 hours to cook, check the temperature on the thermometer after 4 1/4 hours.

4. Meanwhile, mix the stuffing or dressing. Place in a casserole and pop it into the oven during the last hour or so of roasting time.

5. Remove the foil tent after 1 to 1 1/2 hours of cooking time to brown the skin. Brush with vegetable oil to enhance browning, if desired.

6. A whole turkey (and turkey parts) is safe when cooked to a minimum internal temperature of 165  $^{\circ}$ F as measured with a food thermometer. Check the internal temperature in the innermost part of the thigh and wing and the thickest part of the breast. For reasons of personal preference, consumers may choose to cook turkey to higher temperatures.

7. Allow the turkey to set 20 to 30 minutes before carving to allow juices to saturate the meat evenly.

Note: Cooking times do vary. Why? There are many reasons: oven temperature may not be completely accurate, the turkey may be very cold or partially frozen, and/or the roasting pan may be too small which inhibits the flow of heat. The USDA highly recommends use of a meat thermometer to determine doneness of turkey.

The goal of the association is to better share institutional knowledge and regulatory best practices.



At the time Union County included land that now makes up Alexander and a part of Pulaski counties in Southern Illinois.

The reference book includes illustrated township plats that document the names of settlers, squatters, and speculators who occupied the land.

The paths, trails and roads and the ferries that operated on the Mississippi, Ohio and Cache rivers are plotted showing the westward movement.

Stories are included about the settlement of

that came to be known as "Egypt," and the spirit of the people who were once a part of its citizenry.

The history is grounded in the enlightenment period that followed the Revolutionary War and highlights its impact on the establishment of a newly formed country.



#### Governor warns that return to stay-home order is possible

# **Illinois urges residents to stay home for 3 weeks**

SPRINGFIELD – Illinois residents were being urged to stay at home as much as possible for at least the next three weeks as the second wave of COVID-19 outbreaks continues to sweep across the state.

The latest advisory from the Illinois Department of Public Health, IDPH, does not represent a renewal of the stay-at-home order that was in effect this spring, but Gov. JB Pritzker warned Thursday, Nov. 12, that if current trends continue, stricter mitigation orders could be in store.

(The advisory came on a day when Southern Seven Health Department reported 23 new cases of COVID-19 in Union County. As of Nov. 12, a total of 894 cases had been recorded in the county since the pandemic began.)

## Chicago veterans' home opens

The opening of a new Chicago Veterans' Home was commemorated on Nov. 11.

The home is the first state veterans' retirement facility to open in 20 years and the first to serve the Chicagoland area.

Prior to construction of the Chicago home, the closest veterans' homes were located in Manteno and La-Salle, causing hardship for those who wanted to remain in their communities. Completion of the long-awaited facility was made possible through funding in the State of Illinois' Fiscal Year 2020 budget.

"With many community leaders choosing not to listen to the doctors, we are left with not many tools left in our toolbox to fight this," Pritzker said during his daily COVID-19 briefing

in Chicago. "The numbers don't lie. If things don't take a turn in the coming days, we will quickly reach the point when some form of a mandatory stay-at-home order is all that will be left."

The latest guidelines urge all Illinois residents to stay at home as much as possible, leaving home only for work or school if they are not working or learning remotely, grocery shopping, visiting a doctor or getting a COVID-19 test.

He also said the state is increasing its testing capacity at the most-visited testing sites in the state: Aurora, Arlington Heights and Harwood Heights.

A full list of available testing sites statewide can be found at the Illinois Department of Public Health's website, http://dph.illinois. gov/testing.

Earlier on Nov. 12, Chicago Mayor Lori Lightfoot issued a 30-day stay-at-home "advisory" for residents of that city, where the rolling seven-day average test positivity rate hit 13.9 percent on Monday, Nov. 9.

Both Chicago's and the state's advisories extend Employment Security. through the upcoming

especially as we head into the holidays so that businesses, so that schools, so that our veterans' homes can be safe."

Ezike also spoke of recent outbreaks that have occurred at a number of state-run veterans' homes, including one in LaSalle, where more than 150 cases of COVID-19 and nine virus-related deaths have been confirmed among residents and staff.

The new stay-at-home advisory came as the state recorded a new record for the number of people hospitalized with the disease.

As of late Wednesday night, Nov. 11, 5,258 people were reported hospitalized, an increase of more than 200 from the day before. That included 956 people in intensive care units and 438 patients on ventilators.

Over the previous 24 hours, IDPH reported 12,702 newly confirmed or probable cases of the disease out of 100,617 tests performed, for a single-day positivity rate of 12.6 percent.

The preliminary seven-day rolling average case positivity rate was reported at 12.6 percent.

As the number of infections and hospitalizations have been rising in recent weeks, new unemployment claims continued pouring in to the Illinois Department of

During the week that en ed Saturday, Nov. 7, IDES reported, 67,158 workers filed first-time unemployment claims, down roughly 9 percent from the previous week, but still more than six times the number who filed such claims during the same week a year ago.

Assistance, PUA, a federally-funded program for gig workers, independent contractors and others who don't normally qualify for traditional unemployment insurance.

During his briefing, however, Pritzker noted that the PUA system has been plagued by fraud nationwide, and he blamed federal officials for failing to enact adequate controls to prevent fraud when Congress established the program earlier this year.

Meanwhile, Pritzker also used some of the strongest language yet in talking about local elected officials who have so far refused to enforce the state's mitigation orders aimed at controlling the spread of the virus.

'To the elected officials who have chosen to disregard public health guidance, those who have stood up at press conferences to question the data and fuel conspiracy theories, those who have taken their absurd crusade to the courts and lost nearly every single time, those who have flat-out told the businesses in their communities to ignore what their local and state public health departments and experts, some of the best in the nation, are telling them, what is it going to take to get you to be part of the solution?" Pritzker said.

# **Quitting smoking** and the pandemic

Southern Seven Health Department reports that according to the American Cancer Society, ACS, roughly 32.4 million American adults still smoke cigarettes - and smoking remains the single largest preventable cause of death and illness in the world.

Smoking causes an estimated 480,000 deaths every year, or about one in five deaths. And more than 16 million Americans live with a smoking-related disease.

On Nov. 19, Southern Seven Health Department joins with the ACS to encourage all smokers to take part in the Great American Smokeout by making it the first day to a life without cigarettes, vaping and other tobacco products.

For more than 40 years, the ACS has hosted the Great American Smokeout on the third Thursday of November.

The health department explains that within the first 24 hours of quitting smoking, your blood pressure begins to drop, decreasing the risk of heart disease from smokinginduced high blood pressure.

In this short time, your oxygen levels will have risen, making physical activity and exercise easier to do, promoting heart-healthy habits.

The health department encourages smokers not to stop at day one. By day two, your sense of smell and taste improves as your nerve endings start to heal. And this is just the beginning to the healing process your body will go through, the health department says.

#### **Smoking and COVID-19**

For those who smoke, and are concerned about CO-VID-19, the health department says there is little known at this time about the risk of SARS-CoV-2 infection associated with smoking.

However, tobacco smokers may be more vulnerable to contracting COVID-19, as the act of smoking involves contact of fingers, and possibly contaminated cigarettes, with the lips, which increases the possibility of transmission of viruses from hand to mouth.

Smoking waterpipes, also known as shisha or hookah, often involves the sharing of mouth pieces and hoses, which could facilitate the transmission of the COVID-19 virus in communal and social settings.

The Centers for Disease Control and Prevention reported in April that current or former cigarette smokers may increase their risk of severe illness from COVID-19.

According to the World Health Organization, WHO, smoking impairs lung function, making it harder for the body to fight off coronaviruses and other respiratory diseases.

Available research from WHO suggests that smokers are at higher risk of developing severe COVID-19 outcomes and death.

Smoking any kind of tobacco reduces lung capacity and increases the risk of many respiratory infections and can increase the severity of respiratory diseases.
