#### Major winter storm brings sleet, snow, ice News

Notes Items of interest from throughout the Union County area

Happy Valentine's Day to everybody on Feb. 14.

An American Red Cross blood drive is scheduled from noon to 6 p.m. Thursday, today, at the First Baptist Church in Anna.

A succinct description of last week's weather from a local observer: "two and half inches of slick."

The Stinson Memorial Public Library District Board of Trustees is seeking to fill a vacancy. \*\*\*

Planning is underway for the 2022 Pumpkin Town event at the Anna City Park. Pumpkin Town is scheduled to be on display Oct. 20-31. More than 2,000 people visited Pumpkin Town in 2021. \*\*\*

A grand opening celebration is being planned in early April by Dale and Monica Russell with Just Chill, the new concession stand business at the Anna City Park.

A major winter storm last week dumped significant amounts of snow, sleet and freezing rain on the Southern Illinois, Southeast Missouri and Western Kentucky region.

The storm began Wednesday, Feb. 2, and continued on Thursday and Friday, Feb. 3-4.

The National Weather Service office in Paducah reported that an ice storm was experienced across most of Western Kentucky.

A zone of heavy sleet was observed along the Ohio River and in parts of Southeast Missouri.

Farther northwest, several inches of snow fell from Mount Vernon across the Carbondale area into the Ozark foothills of Southeast Missouri.

The winter storm was accompanied by bitter cold temperatures.

Conditions began to moderate early this week. The high temperature on Tuesday in Union County was expected to be around 49 degrees. The forecast was calling for a high of around 51 on Wednesday. Sunshine was expected on both days.

Wintry precipitation recorded by local weather observer Dana Cross in Jonesboro included:

.20 of an inch of ice pellets (sleet) on Feb. 2.

1.5 inches of ice pellets and 1 inch of snow on Feb. 3.

A high temperature of 25 degrees was recorded on Feb. 3. The low was 20. Temperatures recorded

late last week included: Feb. 4: High of 30, low of 15. Feb. 5: High of 31, low of 13. Feb. 6: High of 42, low of 15.

The snow, sleet, ice and cold were part of what the National Weather Service described as a "large-scale and massive winter storm" which impacted the central, eastern and southern United States late last week. The impact of the storm was seen from New Mexico to Maine.

By late afternoon on Wednesday, Feb. 2, the weather service office in Paducah was alerting the region's residents that a major winter storm was underway.

"A prolonged winter storm will bring significant accumulations of sleet, ice and snow to some of the area," the weather service office advised on its website.

"Major travel disruptions are expected across the entire region and some power outages are possible.

"After a brief lull tonight, another wave of heavy mixed wintry precipitation will move into the region early Thursday morning, continuing through the day.'

By Thursday afternoon, Feb. 3, the weather service office was reporting that roadways in the region had "become treacherous in many areas." In some areas, downed trees and power lines had caused power outages.

The weather service office in Paducah issued a winter storm warning for parts of Southern Illinois and Southeast Missouri which was in effect for all of Thursday, Feb. 3.

The weather service office warned that heavy precipitation was possible, with total snow and sleet accumulations of 2 to 7 (continued on page 2)

The coats arrived in early January. Duckworks Lawn Care and Shawnee Mass Transit District helped deliver the coats to their destinations.

## Anna police chief urges everyone to lock vehicles

The Anna Police Department reports that five vehicles have been stolen since the first of the year. Anna Police Chief Bryan Watkins said that four of

the five have been recovered, with minor damages reported to some of the vehicles.

"Each of the stolen vehicles were unlocked," Watkins stated.

There have been multiple unlocked vehicles broken into, with personal property stolen from inside the vehicles.

"Three handguns have been reported stolen from inside unlocked vehicles. None have been recovered," Watkins said.

Anna Police Department officers have increased patrols, stopped numerous traffic violators and have increased pedestrian stops since the thefts increased.

"Several interviews have been conducted and we are making progress on these cases," the Anna police chief said.

The Anna Police Department urges everyone to lock their vehicle and house doors and to do "what you can to make your personal property less attractive to these criminals.'

"Also, please be vigilant and report any suspicious activity to the police at 833-5500," Watkins said.

(continued from page 1) inches and ice accumulations of one tenth of an inch, with locally high amounts possible. Wind gusts of 25 to 35 miles per hour were likely.

"Travel due to the snow, sleet and freezing rain will be extremely difficult and should be avoided unless absolutely necessary," the weather service office cautioned.

Not much traffic was to be seen early Thursday morning, Feb. 3, in the Union County area.

Highways, roads and streets in the county were covered with a mix of ice, sleet and snow

At about 8:30 a.m. last Thursday, electronic signs

at several places in Anna showed a temperature of 19 degrees.

The Illinois Department of Transportation posted information online which showed that state highways in the area were covered with ice or snow last Thursday.

Union County Highway Department engineer Jeff Denny said that 2 to 3 inches of sleet fell during the winter storm. Nearly all of the county was covered with a layer of sleet. Denny noted that sleet is harder to remove than snow.

The highway department had two crews, totaling 13 people, who worked 16hour shifts to clear county highways and roads. "They

did an excellent job," Den- Friday, Feb. 3-4. ny said.

The Union County Sheriff's Office and the Anna Police Department both reported that there had not been any major traffic accidents related to the winter storm.

Last Thursday afternoon, with sleet still falling, the sheriff's office advised that conditions were "pretty rough" and urged everyone to stay home.

The winter storm led to numerous closings and cancellations.

The Union County Courthouse in Jonesboro closed at 2 p.m. Wednesday, Feb. 2, due to the weather. The courthouse remained closed on Thursday and

Union County schools ended their day early on Feb. 2 and remained closed on Thursday and Friday. Bad road conditions were still having an impact on school schedules on Monday, Feb. 7.

Municipal offices in Union County communities closed due to last week's winter storm. Some businesses also closed due to the weather.

The winter storm impacted schedules at Shawnee Community College, Southern Illinois University Carbondale and Southeast Missouri State University in Cape Girardeau.

Trash and recycling pick up were affected in local communities.

Jan. 12-19, when highs were routinely in the 40s or 50s. The month began with temperatures in the 60s in the early morning hours of New Years Day, before temperatures dropped through-

out the day. The two most notable colder periods were Jan. 6-7 and 20-22. Many locations observed highs in the 20s and lows in the single digits or teens during those times.

Jan. 26 and 29 also had lows in the single digits at a number of locations.

#### 60,389 new COVID cases in Illinois

The Illinois Department of Public Health, IDPH, on Friday, Feb. 4, reported 60,389 new confirmed and probable cases of coronavirus disease (COVID-19) in Illinois, including an increase of 608 deaths since reporting on Jan. 28.

The number of cases reported for the week prior to Feb. 4 was less than half as many which had been reported on Jan. 28, a total of 123,812.

The weather service reported that last month was the coldest January since 2018 at all five of its official climate stations.

Wetter Than Normal

A large portion of the region finished the month wetter than normal.

This was the case across all of Western Kentucky, much of Southeast Missouri along and south of a Poplar

Route 13. Much of this area finished the month drier than normal.

The main snow event in January occurred on the 6th, with most of Western Kentucky seeing 3 to 6 inches of snow, while locations further north/west had lower amounts.

January snowfall at Paducah was an inch above normal.

## **Court order invalidates mask, vaccine mandates**

#### Governor, attorney general appeal decision; local school officials urge patience, grateful for support

SPRINGFIELD – Illinois Attorney General Kwame Raoul and Gov. JB Pritzker's administration are asking a state appellate court to set aside a lower court order from late Friday that invalidated the mask and vaccine mandates that the state imposed last year for public schools.

On Friday, Sangamon County Circuit Judge Raylene Grischow granted a temporary restraining order blocking schools from enforcing those mandates, saying the mitigation rules amounted to a kind of "quarantine" and that the Pritzker administration overstepped its bounds by issuing those mandates through emergency rules.

"The judge's decision cultivates chaos for parents, families, teachers and school administrators across the state, and I've asked Attorney General Kwame Raoul to seek to have the ruling overturned with all possible speed," Pritzker said during a news conference Monday.

Beginning in August 2021, Pritzker issued a series of executive orders related to the reopening of public schools.

They included a requirement that schools enforce a mask mandate for all students, staff and visitors; that they require all school personnel either be vaccinated or submit to weekly testing, and that they exclude from school premises for specified periods of time any student or staff member who tests positive for COVID-19 or who has been in close contact with someone who has.

The Illinois Department of Public Health and the Illinois State Board of Education then issued a series of emergency rules to implement the executive orders.

Parents, students and, in some cases, teachers sued roughly 170 school districts across the state seeking to block those mandates. Those cases were eventually consolidated and transferred to Sangamon County.

In her ruling Friday, Gri-

the emergency rules were issued, the Department of Public Health had known about COVID-19 for well over a year and a half and that vaccines had been around for more than nine months.

She then questioned why the rules could not have been developed under the normal process which would have allowed for public comment and legislative review.

She also noted that state law gives the Department of Public Health authority to issue vaccine mandates.

But in this case, IDPH did not issue such a mandate, the governor did, and then the State Board of Education issued rules to carry out the governor's order - something she said was an improper delegation of an executive branch agency's authority.

"The court cannot find (nor did any party provide) any law enacted by the state Legislature that grants the IDPH the authority to delegate and transfer its duties and responsibilities to ISBE and local school districts," Grischow wrote.

She also found that exclusion from school buildings was a form of quarantine, and under state law, people who are ordered quarantined have a right to challenge the order in court and receive due process.

Her order strikes down several provisions of the emergency rules IDPH and ISBE issued in September and specifically restrains the agencies from requiring school districts to enforce mask mandates without a lawful quarantine order from a local health department.

It also restrains them from requiring districts to exclude unvaccinated individuals from the premises who object to weekly testing without first providing them due process.

And it restrains them from excluding individuals who are deemed a close contact with a confirmed or probable COVID-19 case without providing them due process.

The attorney general's office filed immediate notices of appeal in the cases and on Monday filed motions asking for an emergency stay of the

"These requirements which have provided safety and stability to students, teachers, and schools for months – allow schools to protect their students and staff while providing an opportunity to return to in-person learning," the motion stated.

As of Monday afternoon, the 4th District Court of Appeals had not yet ruled on the motion for an emergency stay.

#### Local School Administrators Respond

Several Union County school district administrators posted messages on social media in response to the ruling by the judge in Sangamon County.

Messages dated Sunday, Feb. 6, were posted on Facebook by the superintendents of Anna-Jonesboro Community High School District No. 81, Anna School District No. 37 and Dongola School District 66.

On Monday, Feb. 7, the superintendents of Lick Creek School District No. 16 and Cobden School District No. 17 issued statements which were posted on Facebook.

School officials voiced gratitude for support which has been shown to students, teachers and staff and noted that the current situation could change quickly. Officials also are asking for everyone on both sides of the controversial issue to be respectful of the viewpoints of others.

A-JCHS District 81 superintendent Rob Wright explained in a message to students and parents that the Sangamon County judge's ruling in the case "does not apply to our school district since no one from our district was part of the lawsuit" which had been brought against the mask and vaccine mandates

garding the judge's ruling, "meaning that it may be a short lived decision."

The A-JCHS superintendent said he appreciated patience which has been shown in this matter and voiced "great pride in our students. I realize this is a hot topic with widely varying opinions. Please continue to be respectful of others' thoughts on this matter."

A subsequent "Announcement Regarding Mask Guidance" from the superintendent was posted on social media Monday which read:

"After further review of the recent court decision and more opportunities to discuss with stakeholders in the district as well as legal counsel, Anna-Jonesboro CHSD #81 will adhere to the spirit of the recent ruling and beginning tomorrow, masks will be optional for students and employees. Masks will still be required on student transportation (bus, vans, etc.) as required by federal law. Students will also no longer be excluded from school based solely on being deemed a 'close contact'. Please keep in mind that these circumstances could change at any time based upon future legal proceedings.

Anna School District 37 superintendent Dr. Julie Bullard asked parents and guardians for their "patience and understanding as our district navigates the latest changes to the COVID-19 guidance and rules for Illinois schools."

Bullard said that after consulting with the district's legal counsel, it was unclear if the judge's ruling could be generalized to all school districts in Illinois.

The Anna School District Board of Education planned to discuss the matter at a special meeting which was called for 5:30 p.m. Wednesday, Feb. 9. The meeting was scheduled to take place in the media center at Anna Junior High School.

Until this meeting, it is our intention to continue to operate as we have been during the 2021-2022 school ear. Our goal is to proceed with caution and consistency while meeting the needs of our students with in-person learning." The superintendent thanked parents and guardians for their "continued support of our students, teachers, and staff. It has been a difficult year and finding the balance between COVID-19 mitigations, state mandates, and staffing shortages has been challenging to say the least. We are grateful for your understanding as we work to provide the best education possible in a safe space for our students." Dr. Paige Maginel, superintendent of Dongola School District 66, addressed her message to the district's families, asking for their "patience and understanding as our district navigates

> Maginel said that Dongola is not a party to the lawsuit. She explained that since the temporary restraining order ordered by the Central Illinois judge "does not apply to our district, and because this order is by its very definition 'temporary' and is not a final disposition of the issues, the District will continue with our current plan until the appeal is heard and decided."

> "Until further notice, it is our intention to operate as we have been during the 2021-2022 school year, allowing time to hear from all stakeholder groups including the Board of Education, the Dongola Education Association, the community, and all other interested parties. Our goal is to proceed with caution and consistency for the benefit of our District."

> The Dongola superintendent thanked the community's families "for your continued support of our students, teachers and staff. While it has been a difficult year, we will continue to push forward together."

Lick Creek School District superintendent Brent Boren addressed a message to the district's families.

"Over the past two years, our students have faced many challenges in their learning environment," Boren wrote.

"We have watched them navigate these changes with strong support from home and school.

"On Monday, our students and staff will once again face a change. Some people will come to school wearing masks and some will not. In education, we call this a teachable moment.'

We ask families to take some time prior to Monday to have a conversation with their child regarding the importance of respecting the personal choice of each member of our school community. What a wonderful opportunity to teach about kindness and respect!"



## **DEA reports record** seizure of fentanyl


Drug Enforcement Admin- illegal drugs, the illegal istration, DEA, St. Louis Division broke a fentanyl seizure record for 2021 with nearly 188 kilograms seized through Missouri, Kansas and Southern Illinois.

In addition, agents and task force officers seized 1,848 kilograms of methamphetamine and 73 kilograms of heroin, the division reported in a news release.

The meth seizure amount was also the most in the division's history. Investigators also seized 347 weapons.

Topping off the St. Louis Division's statistics for 2021 were its efforts to curtail money laundering by drug trafficking organizations, seizing and stopping \$15.8 million from reaching its organization leaders.

"With overdose deaths soaring nationwide, the



ST. LOUIS - The federal DEA's efforts to seize proceeds, and the guns associated with these violent enterprises is more important than ever," said special agent in charge Todd Zimmerman.

"The credit goes to our agents, task force officers, and the staff who support them. We'll continue to do our part to prevent drug trafficking organizations from profiting from their criminal activities and causing harm in our communities."

Fentanyl, a synthetic opioid, is used for pain in a pharmaceutical setting and is 50 times more potent than heroin.

However, drug cartels have been attempting to distribute fentanyl in record amounts, leading to an alarming increase in overdose deaths.

DEA put out a safety alert in September about fentanyl in counterfeit pills, which is responsible for 75 percent of opioid overdose deaths.

DEA's St. Louis Division seized 82 kilograms of fentanyl in fiscal year 2020 and 104 kilograms in fiscal year 2019.



WEDNESDAY

I am reminding you, brothers and sisters, of the gospel I preached to you, which you indeed received and in which you also stand. Through it you are also being saved, if you hold fast to the word I preached to you, unless you believed in vain.

For I handed on to you as of first importance what I also received: that Christ died for our sins in accordance with the Scriptures; that he was buried; that he was raised on the third day in accordance with the Scriptures; that he appeared to Cephas, then to the Twelve. After that, Christ appeared to more than five hundred brothers at once, most of whom are still living, though some have fallen asleep. After that he appeared to James, then to all the apostles.

Last of all, as to one born abnormally, he appeared to me. For I am the least of the apostles, not fit to be called an apostle, because I persecuted the church of God. But by the grace of God I am what I am, and his grace to me has not been ineffective. Indeed, I have toiled harder than all of them; not I, however, but the grace of God that is with me. Therefore, whether it be I or they, so we preach and so you believed. From 1 Corinthians

While the crowd was pressing in on Jesus and listening to the word of God, he was standing by the Lake of Gennesaret. He saw two boats there alongside the lake; the fishermen had disembarked and were washing their nets.

Getting into one of the boats, the one belonging to Simon, he asked him to put out a short distance from the shore. Then he sat down and taught the crowds from the boat. After he had finished speaking, he said to Simon, "Put out into deep water and lower your nets for a catch." Simon said in reply, "Master, we have worked hard all night and have caught nothing, but at your command I will lower the nets."

When they had done this, they caught a great number of fish and their nets were tearing. They signaled to their partners in the other boat to come to help them. They came and filled both boats so that the boats were in danger of sinking. When Simon Peter saw this, he fell at the knees of Jesus and said, "Depart from me, Lord, for I am a sinful man." For astonishment at the catch of fish they had made seized him and all those with him, and likewise James and John, the sons of Zebedee, who were partners of Simon.

Jesus said to Simon, "Do not be afraid; from now on you will be catching men." When they brought their boats to the shore, they left everything and followed him. From the Gospel of Luke





## Southern Seven urges everyone to be aware of their heart health

Cardiovascular disease, also known as heart disease, is the leading cause of death for men, women and people of most racial and ethnic groups in the United States.

Southern Seven Health Department says that according to the Centers for Disease Control and Prevention, CDC, one person dies every 36 seconds in the United States from heart disease.

And every year, about 805,000 people in the United States have a heart attack, with most experiencing it for the first time.

February is American Heart Month. Southern Seven Health Department reminds everyone to take note of their heart health.

Steps which can be taken include having blood pressure checked regularly, knowing the signs of a heart attack and talking with a doctor about steps which can be taken to prevent heart disease - how best to treat a diagnosis of heart disease.

According to the CDC, roughly 659,000 people in the United States die from heart disease each year; that's one in every four deaths.

Coronary artery disease, also known as coronary heart disease, is the most common type of heart disease, resulting in more than 360,000 deaths in 2019.

Coronary artery disease affects about 18.2 million adults age 20 and older. About two in 10 deaths from coronary artery disease happen in adults less than 65 years old.

Southern Seven Health Department advises that high blood pressure, high blood cholesterol and smoking are key risk factors for heart disease.

Several other medical conditions and lifestyle choices can also put a person at a higher risk for heart disease, including diabetes, being overweight or obese, having an unhealthy diet, lack of exercise and excessive alcohol use.

Most people don't know they have heart disease until they have a heart attack. It is estimated that one in five heart attacks is silent. And although the person is not aware of it, the damage has been done.

The signs of a heart attack can be different for everyone, but the most common warning signs are pain or discomfort in the chest, lightheadedness, nausea or vomiting, jaw, neck or back pain, discomfort or pain in left arm or shoulder, and shortness of breath.
