Four-way stop project underway in Anna In separate project, natural gas line cut, leading to evacuation of area Monday afternoon

News Notes Items of interest from throughout the Union County area



Just never know what you might see in Anna on a warm afternoon in July.

An American Red Cross blood drive is planned Thursday, Aug. 9, at the First Baptist Church in Anna.

Reminder: The Union County Emergency Management Agency and the local Amateur Radio Club are planning to conduct an emergency drill from 2 p.m. to 3 p.m. on July 28. The drill will involve a simulated tornado emergency. In the event of bad weather, the drill will be cancelled.

Union County is expected to have a good peach crop in 2018. The crop is about a week to 10 days late this year, compared to previous years.

Peach Festival banners are on display in Cobden.

The Union County Museum in Cobden plans to be open on Friday and Saturday during the upcoming Peach Festival weekend.

A major street project got underway on Monday morning, July 23, in Anna, when the busy four-way stop intersection at Illinois Route 146 (Vienna Street) and Main Street in downtown Anna was closed to all traffic.

The intersection was closed for concrete pavement replacement work.

The Illinois Department of Transportation reported that the work is scheduled to be completed by 7 p.m. Monday, July 30, weather permitting.

While the work is being done, marked detours have been in place to direct motorists around the closed intersection.

Access to businesses in the areas has remained open.

Anna Police Chief Mike Hunter said that as of Tuesday morning, traffic had been moving smoothly in the area.

E.T. Simonds Construction Company of Carbondale is the project's general contractor.

Gas Line Cut

At about 2 p.m. Monday, local officials issued an evacuation order for part of the city in response to an incident in which a municipal natural gas line was accidentally cut while maintenance work was being done along nearby East Vienna Street.

The maintenance work was being done by the Illinois Department of Transportation separate from the project at the four-way stop. The order was quickly

lifted after city crews shut off the natural gas.

When the cut in the line occurred, the Anna Police Department posted a notice on Facebook which alerted the public about the incident.

The Illinois Office of Tourism this month announced that 28 new makers were joining the Illinois Made program, including Rendleman Orchards.

Rendleman Orchards is an Illinois agribusiness which produces peaches, nectarines, apples and vegetables. The fruits and vegetables are shipped to a variety of markets.

The Rendleman Orchards Farm Market, which is open for the season, offers such products as apple butters, sauces, and the ingredients to make a peach crisp or peach cobbler – along with the family recipes to create the baked treats.

Illinois Made, which was launched in 2016, features a wide range of small businesses, from locally owned bakeries and craft breweries, to pottery shops, soap artisans and orchards.

"The Illinois Made program promotes authentic travel experiences throughout the state," Jobe said.

"By expanding this successful program, we're encouraging visitors to dis-

Tourism revenues boost Southern Illinois economy

Tourism has announced that both international and domestic travel expenditures reached \$39.5 billion in 2017, which was a \$1.1 billion boost to the state's economy since 2016.

Visitors to the state hit an all time high in 2017 with an additional 1.6 million travelers from 2016 contributing to an increase of visitor spending, tax revenue and local jobs.

Carol Hoffman, executive director of the Southernmost Illinois Tourism Bureau, has shared an update on tourism's impact on the region's economy.

The Southernmost Illinois Tourism Bureau is the certified bureau working with the Illinois Office of Tourism to promote the Southernmost 10 counties of Illinois, including Union County.

Southernmost Illinois played a role in the state's added economic domestic growth, with \$225.8 million in travel expenditures (a 2.6 percent increase) and \$7.97 million in local tax revenue (a 2.8 percent increase).

More than 6,000 jobs were created across the state as a result of visitor spending, with 30 of them in Southernmost Illinois.

"Illinois is the perfect destination for anyone looking for a new experience, whether it's an outdoor adventure, a scenic road trip, incredible nightlife, or a family-friendly activity: there truly is something for everybody," said Cory Jobe, director of the Illinois Office of Tourism.

"The added boost in state and local tax revenue is a testament to the continued

The quality of life for local residents is greatly enhanced by tourism promotions and development, Hoffman said.

"Visitors are discovering the amazing adventures in Shawnee Forest Country. In addition to the outdoor activities, they are discovering the area wineries and breweries, and enjoy staying in unique cabins, cottages, inns, tree houses and a variety of vacation rentals."

Hoffman shared the following information about Illinois tourism in 2017:

Every \$1 invested in Illinois tourism generates \$9 in economic impact for the state.

Illinois welcomed 111 million domestic visitors.

Of Illinois' 111 million domestic visitors, 17 percent were for business and 83 percent were for leisure. In the past 10 years, domestic travel to Illinois has increased by 23 million visitors.

The visitor expenditures generated by domestic visitors supported 308,490 jobs in 2017, which was an increase of 6,040 jobs since 2016.

Domestic travelers spent \$36.3 billion in Illinois during 2017, a 3.3 percent increase from 2016.

The Illinois Office of Tourism receives domestic visitor volume estimates from DK Shifflet and international visitor numbers from Tourism Economics. Visitor expenditures, tax revenue and jobs numbers come from U.S. Travel Association.

Registration for the 2018-2019 academic year is scheduled Aug. 1 at Jonesboro School.

Hours for registration are planned from 8 a.m. to 1 p.m. and from 3 p.m. to 6 p.m.

Registration will be in the gymnasium foyer at the school. The school noted that all returning students, new students and kindergarten students must attend registration.

A consumable fee of \$25 will be required for those who register.

A copy of a student's birth certificate is required for those who are registering for the first time.

All students are required to show two proofs of residency.

Student registration for 8th grade must be registered.

> All parents who want to register a child must bring proof of residency.

Two forms of proof are from 11 a.m. to 6 p.m. on required. One Category I document is required.

> Category I documents include a most recent property tax bill, mortgage papers, a signed and dated lease and proof of last month's pavment, a letter of residence from a landlord in lieu of a lease (the form is provided by the district) or a letter of residence to be used when a person is seeking to enroll a student who is living with a district resident (the form is provided by the district).

One Category II document is required, as well.

Category II documents include a driver's license, vehicle registration, voter registration, a most recent cable television or credit card bill, a current public aid card, a current homeowner's/renter's insurance policy and premium receipt payment, or a most recent gas, electric or water bill.

Parents who want to enroll new students (transfers from other schools) are advised to bring all of the above documents, along with the child's birth certificate and Social Security card.

Final registration will be pending district verification of proof of residency which is provided.

Warm, wet June recorded

Illinois experienced its 11th warmest and 14th wettest June on record, according to state climatologist Jim Angel at the Illinois State Water Survey in Champaign.

The statewide average temperature was 75.0 degrees, which was 3.1 degrees above normal.

The statewide average precipitation was 6.36 inches, which was 2.15 inches above normal.

The greatest monthly total precipitation for June in Illinois was 14.58 inches at Rockford.

Precipitation was especially heavy across northern, east-central and southeastern Illinois, with widespread amounts in the 10 to 14 inch range.

Meanwhile, parts of western and Southern Illinois received less than 3 inches of rain.

Hot weather was common in June. The number of days that hit 90 degrees or higher ranged from about three to four days in Northern Illinois to about half the month in the St. Louis area.



A New York University survey of the 10 commandments showed "having no idols" ("graven image" - Ex. 20:4) came in 9th out of 10th in importance, 10th being the least important. Many people today don't consider idolatry a sin, but we must understand that idol worship is "idle worship" – "idle" meaning: frivolous and a waste of time; ineffective.

Throughout history, humanity has been plagued with idolatry. In II Kings 18, Elijah challenged the prophets of Baal to have their god send down fire to light a burnt offering. 450 prophets of Baal tried from morning until noon to no avail. In verses 36-37, Elijah petitioned the God of Heaven to send down fire and, "Then the fire of the LORD fell, and consumed the burnt sacrifice, and the wood, and the stones, and the dust, and licked up the water that was in the trench" (v. 38). Elijah proved the existence and power of the true and living God (I Thess. 1:9).

In Isa. 44:12-20, Isaiah points out the folly of using pieces of the same log for fire to cook over and for warmth, and to also fashion a graven image to worship.

In I Chron. 14, the Philistines plotted to attack Israel under David's leadership. The Lord promised to help David defeat the Philistines (I Chron. 14:10). When the enemy was defeated and left their "gods" behind, David ordered them burned (v. 12).

When Paul arrived in Athens (Acts 17), he was shocked by the degree of idolatry he found.

Clearly, from these Bible examples, there is no power in idols, but is idol worship a problem today?

Idol worship extends beyond bowing down to a graven image. Anything we place greater in importance than God becomes an idol.

For example, love of money is an idol to many. Paul wrote to Timothy and warned, "...the love of money is the root of all evil" (I Tim. 6:10). Jesus warned, "Ye cannot serve God and mammon" (Mt. 6:24 - "mammon" meaning "treasure" or "riches"). Yet, in spite of these clear Bible warnings, so much of the world is more concerned with the pursuit of money than with serving God faithfully. The rich young ruler of Luke 18 was instructed by Jesus to sell all that he had and distribute to the poor in order to attain eternal life, but "when he heard this, he was very sorrowful: for he was very rich" (Luke 18:24).

Others may idolize fame, power, or pleasure. These things are not intrinsically evil, but when they take precedence over God, they become our idols - they become sinful because they separate us from God.

Dear Reader, come study with us at the Anna church of Christ and let us help you build a proper relationship with God. Remember the gods of the Philistines: they failed. They were collected & burned (I Chron. 14:12). Idol worship will not save you for there's no power in idols! The God of David brought victory! Learn more about Him with us and allow Him to bring you eternal victory! Remember, idol worship is idle worship.





Detention center escapee captured in Union County

law enforcement agencies were involved in the search for a man who walked away from the Pulaski County Detention Center at Ullin last week.

Union County Sheriff Scott Harvel reported that the man was apprehended at about 2:30 p.m. Thursday, July 19, in the Foster Lane area near new U.S. Route 51, about 3 miles south of Anna.

The sheriff posted on Facebook that the escapee had been captured.

Harvel said the man was

County Sheriff's Office deputy.

The man, identified as Alexis Chacon, 19, of Honduras, was taken into custody without incident. He was not armed.

The man may have traveled as far as 15 miles on foot. He may have had to swim across the Cache River. He was reported to have stopped at a residence between Dongola and Anna and asked for water.

Personnel from multiple apprehended by a Union included woodlands, pastures and corn fields.

The man who was apprehended in Union County was one of two men who were reported to have walked away from the detention center on Tuesday, July 17. The other man was reported to have been taken into custody on the day the two fled from the center.

After the man was taken into custody last Thursday, he was turned over to the custody of the Pulaski County Sheriff's Department.

The Union County Sheriff's Office's K-9 unit was involved in the search for the man.

One person was reported to have been injured in a two-vehicle traffic accident which happened Friday, July 20, on Interstate 57 in Union County.

Illinois State Police District 22 at Ullin reported that the accident occurred at 2:39 p.m. Friday at milepost 23.5 in the southbound lane of the interstate.

The accident involved a 2016 Volvo truck tractor which was pulling a 2016 utility semi-trailer and a 2002 Freightliner truck tractor which was pulling a flatbed semi-trailer.

State police reported attempting to re-enter In-

The unit was traveling south on Interstate 57 near milepost 23 in Union County.

State police reported that the semi left the highway on the right, struck a ditch and overturned onto the driver's side before coming to a rest.

The 12-year-old boy was reported to have been a passenger in the unit. He was ejected from the vehicle and sustained fatal injuries.

The driver was identified as Robert James Petersen, 34, of Killeen, Texas. The driver was reported to have been restrained and entrapped in the vehicle.

the relationships between water, friction and mineral chemistry could lead to a better understanding of earthquake dynamics, researchers said in a new study.

Engineers at the University of Illinois at Urbana-Champaign used microscopic friction measurements to confirm that, under the right conditions, some rocks can dissolve and may cause faults to slip.

The study, published in the journal Nature Communications, closely examines how water and calcite, a mineral that is very common in the Earth's crust, interact at various pressures and groundwater compositions to influence frictional forces along faults.

"Water is everywhere in these systems," said Rosa Espinosa-Marzal, a civil and environmental engineering professor and coauthor of the study.

"There is water on the surface of minerals and in the pore spaces between mineral grains in rocks.

The rock surfaces that slide past each other along faults are not smooth. The researchers zoomed in on the naturally occurring tiny imperfections or unevenness on rocks' surfaces, called asperities, at which friction and wear originate when the two surfaces slide past each other.

"The chemical and physical properties of faulted rocks and mechanical conditions in these systems are variable and complex, making it difficult to take every detail into account when trying to answer these types of questions," Espinosa-Marzal said.

"So, to help understand water's role in fault dynamics, we looked at a scaleddown, simplified model by examining single asperities on individual calcite crystals."

For the experiments, the team submerged calcite crystals in brine solutions at various concentrations and subjected them to different pressures to simulate a natural fault setting.

tion, they used an atomic force microscope to drag a tiny arm with a silicon tip – to simulate the asperity – across the crystal to measure changes in friction.

In most of the experiments, the researchers first found what they expected:

As the pressure applied on the crystals increased, it became more difficult to drag the tip across the crystal's surface.

However, when they increased pressure to a certain point and the tip was moved slowly enough, the tip began to slide more easily across the crystal.

"This tells us that something has happened to this tiny asperity under higher pressures that caused a decrease in friction," said graduate student and coauthor Yijue Diao.

"The atomic force microscope also allows us to image the crystal surface, and we can see that the groove increased in size, confirming that calcite had dissolved under pressure. The dissolved mineral and water acted as a good lubricant, thereby causing Once the crystals were in the observed weakening of

"This shows that studies such as these warrant serious consideration in future work," Espinosa-Marzal said.

The researchers acknowledge that there are still many questions to address related to this research.

However, their work demonstrates that certain brine-calcite interactions, under applied stress, induce dissolution and decrease the frictional strength at the single-asperity scale.

"Our research also suggests that it might be possible to mitigate earthquake risk by purposely changing brine compositions in areas that contain calcite-rich rocks. This consideration could be beneficial in areas where fracking is taking place, but this concept requires much more careful investigation," Espinosa-Marzal said.

"As a young scientist who works at the nanoscale, I never thought that earthquake dynamics would be the type of thing I would be researching," Diao said.

"However, we have learned so much about things at the macroscale that nanoscale studies like ours can reveal new critical insights into many largescale natural phenomena."

The Cache River

The largest stream in the middle of old Johnson County is the Cache River, known also as the Cash. This slow-moving river was significant enough to the early explorers that it received the designation of "river" rather than "creek." This river was named by the earliest explorers in this part of the country. Known officially today as the "Cache," this river was known in the early days as the "Cash." The early records of Johnson County always spell the name C-A-S-H. The obvious question is how did these two spellings come into being.

Several explanations have been given as to how Cache got its name. One of the most interesting stories concerning this and perhaps the most authoritative, seems to be the most accurate account. According to the story, it happened as Sieur Charles Juchereau de Saint Denis, known simply as Juchereau, made his journey across the Illinois Country to the Juchereau Tannery. This is the story, written in 1931, of how Cache got its name. The writer, W.N. Moyers, uses the modern place names when identifying different locations. He says:

furnished "Roenza Juchereau a guide to show him the crossings over Cache River, and the trail to the Ohio. The route from Olive Branch was along the foots of the hills just as runs the present public road to the Hargus store site, on the right bank of Sandy Creek; thence down that creek nearly to its mouth; and thence up-stream on Cache to the Big Drift. This drift was a mile below the Village of Tamms, by land lines/ some United States surveyors in 1807 reported that the center of Cache on that land line could not be found; and in 1903, some surveyors working for the state of Illinois, in very dry weather failed to find the main channel. There has been a big drift at that point every time a record of it has been made, and there was such drift there in November, 1702. Juchereau's party crossed the Cache River at this point; and as they could hear the running water under the drift, but could not see it, one of them (perhaps Father Mermet) exclaimed: "Ce crique est Cache" (this creek is hidden). And it has been called Cache from that date to

According to this story, the Cache meant a "hidden place." The early pioneers who were not

educated, highly didn't bother to ask how this river was pronounced; they just simply spelled it the way it sounded. Cash was the name recorded countless times in the early records. It would be difficult to say when it became known as Cache again.

Cache River has two forks; one that runs westward from near Vienna and one that runs northeastward from that point. The northeast fork is now known as the Little Cache, but in the early days, the settlers considered this fork to be the main channel. It will be noted that the area northeast of where Vienna sits today, was referred to as Cash Township in the early days.

Cache River has always been a hindrance or a blessing to people living near it. It was a barrier but it was also a treasure trove of wildlife.

A note concerning the Juchereau group. These are the people that established the large tannery along the Ohio River near Grand Chain. They were responsible for the extermination of the bison, or buffalo, in Southern Illinois. Contributing to this, severe cold winters decimated the herds on the plains of Central Illinois

Mars Opposition viewing event scheduled at SIU

an opportunity to see the planet Mars during a special observation event planned at Southern Illinois University Carbondale.

The Mars Opposition viewing event is planned from 8:30 p.m. to midnight on July 27 at the SIU farms astronomy observation area west of the campus.

The event, hosted by SIU's Department of Physics and the Astronomical Association of Southern Illinois, is free and open to the public. Bob Baer, a specialist with SIU's physics department, said the event is special for amateur astronomers and stargazers because it provides an opportunity to see Mars while it is close to the Earth and bright.

Sky gazers will have through opposition every two years, it has not been this close since 2003.

"Late in July, the distance will shrink to about 35 million miles, which is significantly less than the average distance of 140 million miles that separates the planets," Baer said.

"At this relatively short range, we can observe some detail on the surface of Mars, including the polar icecaps, when viewing through a portable telescope." 

State public health officials continuing investigation of foodborne illness outbreak

of Public Health, IDPH, continues to work with local, state and federal public health officials to investigate an increase in the number of cyclospora illnesses in counties all across Illinois.

Since mid-May, IDPH has received confirmation of 243 cases of cyclosporiasis, an intestinal illness caused by the microscopic cyclospora parasite.

Of those, 92 reported eating salads produced for Mc-Donald's restaurants in the days before becoming ill.

A new outbreak of cyclosporiasis linked to a private event at the Evanston Golf Club in Skokie was recently identified, IDPH reported July 20.

"Our investigation includes interviewing people who have become ill to learn what they ate, where they ate it, when, and if there are any commonalities," IDPH director Dr. Nirav D. Shah said.

"Additionally, we're tracing any implicated foods to identify the manufacturer, producer, supplier, distributor, and all other points of contact to identify a source. If you feel like you may have been exposed to a foodborne illness and have symptoms, contact a health care provider."

People can become infected by consuming food or water contaminated with feces (stool) that contains the parasite. Cyclospora is not spread directly from one person to another.

Symptoms begin about a week to up to two weeks af-

The Illinois Department ter exposure, although some people who are infected may not have any.

> Symptoms may include the following: Frequent bouts of watery diarrhea (the most common symptom). Loss of appetite and weight. Cramping, bloating, and/or increased gas. Nausea (vomiting is less common). Fatigue. Lowgrade fever.

Cyclospora infection can be treated with specific antibiotics. If not treated, the illness may last for a few days to a month or longer.

Previous cyclosporiasis cases have been linked to various types of imported fresh produce including raspberries, basil, snow peas and lettuce.

Illinois case counts can be found on the IDPH website, and more information about outbreaks can be found on the Centers for Disease Control and Prevention website.

A presentation titled "Hummingbirds: From Flowers to Feeders and Beyond" is planned throughout the morning.





University of Illinois Extension energy and environmental stewardship educator Jason Haupt remembers that his childhood summers were spent at the pool or just running around the woods and creeks with his friends.

Summer offers so many opportunities to explore and experience nature. Haupt shared some ideas on how to get out in nature this summer.

Go for a hike.

"I know that summer is hot and that hiking does not sound all that fun, but there is so much to be seen and heard when you are on a hike in the summer," Haupt said.

Hiking in the woods is so much cooler than being out in the open. The temperature in a wooded area is much cooler than out in the open sun.

When you get down into some of the low spots on your hike you will notice the temperature change even more. It makes the woods and the valleys in the woods that much more appealing.

The bright flash of a cardinal flitting through the trees or the sight of a woodpecker climbing up and down a tree is always exciting.

The sounds of the woods are just as rewarding as the views. If you take time to listen you will hear birds all around you and the simple serenity all around you.

Camping.

"I love to go camping even in the summer. I love to wake up to the sound of birds singing and I always feel more refreshed for having slept out in the open," Haupt shared.

You do not have to go far to find a good place to camp. If you have never been camping, find a friend to take you and you might just find your next obsession.

Just sit in nature and look and listen.

No matter where you go there is a flurry of activity in the summer. The beauty of prairie areas in full bloom is simply breath taking. The flurry of life in the prairie is a stark counterpoint to the serenity of the woods. There is constant movement and activity in the prairies.

The rapid movement of the birds and butterflies and the gentile ebb and flow of the wind over the grasses and flowers are accompanied by the gentle sounds of the wings of the insects and the song of the blackbirds.

An evening spent on the edge of a prairie will show you hundreds of insects buzzing around, and bumble bees and butterflies are just the beginning. Birds and bats will also be present. Swallows and swifts will be doing acrobatics and bats will join them as it starts to get dark.

Nature is so very important to every aspect of life and should be a part of everyone's life. Nature is so much closer than many people think.

Even in the most urban environments in Illinois nature can be found and easily accessed. There are nature preserves throughout Illinois including in the Chicago area. Even in the urban natural areas there is a sense of serenity and the sound of the cities quickly fades away.


