Snowy Monday morning in Union County

Motorists had a snowy commute on Monday morning in the Union County area. Snow which was falling early in the morning covered area streets, roads and highways. The accompanying picture was taken shortly after 8 a.m. Monday at the intersection of South Main and Davie streets in downtown Anna.

Temperature drops from 60s to 20s in less than 24 hours Snow, sleet, ice, bitter cold chill Union County

On Thursday, Jan. 11, the high temperatures was 64 degrees in Union County.

Less than 24 hours later, the county was under a covering of sleet and snow and the high temperature had dropped into the 20s.

Another round of wintry weather arrived Sunday evening and Monday morning. The area received 3 inches of snow.

Monday's snow was followed by bitter cold weather and arctic wind chill readings.

The National Weather Service office in Paducah on Monday issued a wind chill advisory. The advisory was in effect from midnight until 11 a.m. Tuesday. The advisory covered Southern Illinois, Southeast Missouri and Western Kentucky. The weather service advised that wind chills during the period expected to range from zero to 15 degrees below zero.



The high temperature on Tuesday was forecast to be around 13 degrees, followed by a low of around 4. The high was expected to reach around 23 on Wednesday.

Stalking: Officials promote public awareness

January is National Stalking Awareness Month. Local officials are working to make the public more aware of a crime that affects 3.4 million victims each

year. As part of the effort to help make the community more aware of stalking, a press conference was held Wednesday morning, Jan. 10 at the Union County

Courthouse in Jonesboro. Officials also highlighted the importance of timely reporting for victims of stalking.

Presentations were shared at the press conference by Union County State's Attorney Tyler R. Edmonds, Union County Sheriff Scott Harvel and Cathy McClanahan, who of The Women's Center in Carbondale.



State police responded to more than 1,000 calls for service in 2017

Illinois State Police District 22 has released a review of activities for 2017.

The statistics were released by Lt. Michael Alvey, who is the interim commander of the district.

The sheriff noted during the press conference that "our mission is quite simple: to promote awareness and educate not only the victims, but also the citizens of this community so that everyone has a better understanding about stalking."

Stalking is a Felony

Edmonds reminded those at the event that stalking is a felony in Illinois and a crime in all 50 states and the District of Columbia.

The state's attorney said that many victims and criminal justice professionals underestimate the seriousness and impact of stalking.

He explained that stalking is defined as a course of conduct directed at a person that would cause a reasonable individual to feel fear.

In one of five cases, stalkers use weapons to harm or threaten victims. Stalking is one of the significant risk factors for homicide in abusive relationships.

Victims of stalking suffer anxiety, social dysfunction and severe depression at much higher rates that the general population. Many lose time from work or have to move as a result of their victimization.

Stalkers Seek to Frighten, Control

"Stalking is a serious crime that often goes unreported or unrecognized," Edmonds stated.

"Stalkers seek to frighten and control victims through intimidation and harassment. These behaviors often escalate and that makes timing critical. Timely reporting and timely prosecution can save lives."

Unlike other crimes, officials noted, stalking is not a single, easily identifiable crime.

Union County Sheriff Scott Harvel said that as of mid-morning Friday, one minor traffic accident had a winter storm warning

series of acts, a course of conduct directed at a specific person that cause fear in the victim.

Stalking may take many forms, such as assaults, threats, vandalism, burglary or animal abuse, as well as unwanted cards, calls, gifts or visits.

One in four victims reports that the stalker uses technology, such as computers, global positioning system devices or hidden cameras, to track the victim's daily activities.

"Victims should trust their instincts and report stalking behaviors to law enforcement," Sheriff Harvel said.

"Communication with police is critical – victims should tell police when these are not isolated incidents.'

Keep a Record

The sheriff also strongly urged victims "to keep a log of the stalker's behavior and save texts, emails and social media posts to share with police."

"Just as important," the sheriff stated, "it is the duty of law enforcement to ask the appropriate questions to identify these patterns and collect the vital information to establish a 'course of conduct' in an effort to effectively prosecute (the stalker) and protect the victims of such crimes.

"It is my recommendation that all forms of unwanted behavior directed to any victim should be reported to law enforcement.

"Certainly, when the unwanted behavior rises to a level of imminent danger to life or safety, the victim should immediately report the incident to 911."

McClanahan shared "four golden rules for stalking victims":

Have no contact with the stalker (with emphasis on "no"). Tell others. Increase personal protection. Collect evidence/document.

Difficult to Recognize

Officials who spoke at the press conference explained that stalking is difficult to recognize, investigate and prosecute.

Stalkers fit no standard psychological profile. Many stalkers follow their victims from one jurisdiction to another, making it difficult for authorities to investigate and prosecute their crimes.

Communities that understand and recognize stalking can support victims and combat the crime, officials noted.

Take Action

Edmonds, Harvel and McClanahan joined to encourage victims to take action if they are being who may be interested in stalked. Those actions include:

•Trust your instincts. Don't let others pressure you to downplay the stalker's behavior.

•Call the police. Report stalking to police. When it isn't an isolated incident, give police the full story, explaining the pattern of behavior. If you feel you are in immediate danger, call 911.

•Keep a log. Keep a cluding the date, time and location.

•Save emails, texts and social media posts. Save any written communication from the stalker to provide to police.

One of the workshops is set for March 1 at the Franklin County Extension office in Benton.

On the day of the workshop, registration will open at 8:30 a.m., with the training program starting promptly at 9 a.m.

The Livestock Management Facilities Act of 1997 requires:

Facilities with 300 or more animal units to have at least one employee certified in proper manure handling procedures.

For facilities with 300 to 999 animal units, the employee either must attend a workshop or pass the Illinois Department of Agriculture's Certified Livestock Manager exam.

An employee of facilities with more than 1,000 or more units must do both to achieve certification.

To register for a workshop, call University of Illinois Extension at 217-244-9687 or go online to www. regonline.com/CLMT2018. The cost is \$35.

If more than one employee from the same farm signs up, each registration after the first will cost \$25.

The workshops will use the instructional manual for the national Livestock and Poultry Environmental Stewardship, LPES, Curriculum, which can be purchased for \$67.50 by calling 1-800-345-6087. The manual can also be purchased in an electronic form on CD for \$32.50.

The curriculum is available for free online on Extension's livestock training website.

Organizeers noted that for those who have a manual or CD from 2003 or newer, they will not need to purchase a new one.

Producers also have the option of taking an online training that consists of five modules and four quizzes.

Passing them is the equivalent of having attended a workshop, but does not substitute for passing the certified livestock manager exam.

There is no charge to take the quiz online, other than the cost of the manual. Registration for the







The payments are part of settlements the Illinois attorney general's office has reached over the last several years with manufacturers of LCD monitors installed in electronic devices including TVs, notebook computers, cell phones and MP3 players.

The settlement checks are scheduled to be issued during the first quarter of 2018.

The checks will expire 90 days after issuance, so individuals and businesses that receive checks should cash them promptly, Madigan advised.



AP pilot program designed to help rural high school students

A new pilot program has been unveiled that is designed to give students at rural high schools in Illinois access to online Advanced Placement, AP, classes to better prepare them for college.

The program was unveiled by Lt. Gov. Evelyn Sanguinetti.

A new initiative of the Governor's Rural Affairs Council, GRAC, that Sanguinetti chairs, the AP pilot program kicked off with classes for 75 students at 10 high schools in rural areas across the state.

Sanguinetti held news

"AP classes help prepare students for college and can even make college more affordable, but unfortunately access to AP classes is extremely limited in rural areas," Sanguinetti said in a news release.

"This pilot program will test the feasibility of expanding AP classes through distance education so that students in rural Illinois will get the same opportunities to learn as their counterparts in the urban areas of our state."

'Concern exists that small rural schools have greater difficulty preparing students with the skills necessary for successful college careers because of the lack of AP or specialized coursework," said Dr. Bobbi Mattingly, superintendent of Regional Office of Education No. 11.

"Distance education has the potential to provide more choices which in turn better prepares rural youth to attend college."

A hedge apple by any other name...

There it sat. All by itself. In the midst of melting ice on the surface of a frozen pond in Union County. Maybe the pond is the place where all of those big fish are caught. You know. The famed "local farm pond."

I'm not sure why the object on the melting ice caught my attention. Maybe it was the object's bright green color in the midst of an interesting icy pattern.

The object was a lone hedge apple. The hedge apple also is know as an Osage orange. And as a horse apple. And as a monkey brain.

Until last week, quite honestly, I didn't know about horse apple. Or monkey brain. And, quite honestly, until last week, I didn't know much of anything about hedge apples.

I know we see a lot of hedge apples during the fall in Union County. They make wonderful decorations, along with pumpkins and other squashes and gourds.

For some reason, my curiosity was piqued after seeing the hedge apple on the melting ice. Once again, thanks to that wonder of the modern age, AKA the internet, I was able to learn a little bit more about this fruit.

I guess that was probably the first thing I learned. The hedge apple is a fruit. Specifically, it's the fruit of the osage orange tree.

The University of Nebraska Lincoln Extension website suggested that I wasn't the only one who didn't know much about the hedge apple. The website had an article which explained: "Many people have heard that these fruits can be used as an insect repellent, but the truth is that many people don't know much else about this unusual tree and its fruit."

For example, and here comes your word for the week, did you know that the Osange orange is "dioecious, meaning that the male and female flowers are produced on separate trees." And how do you tell a female tree from a male tree? Just pick one up and look at its backside.

In September or October, the female trees produce fruit which is about 3 to 5 inches in diameter that falls to the ground.

The tree is native to "a small area in eastern Texas, southeastern Oklahoma and southwestern Arkansas. This region is the home of the Osage Indians which gives the tree its common name. Settlers found that the Osage orange transplanted easily, tolerated poor soils, extreme heat and strong winds and had no serious insect or disease problems."

The trees were "widely planted in the Midwest as a living fence because, when pruned into a hedge, (they) provided an impenetrable barrier to livestock. The development of barbed wire curtailed its widespread planting, but many Osage orange trees can still be found in fence rows."

The tree's wood is said to be "extremely hard, heavy, durable and shrinks or swells little compared to the wood of other trees. The wood is used for fence posts, treenails, furniture and archery bows. In fact, many archers consider the wood of the Osage orange to be the world's finest wood for bows."

The wood of the Osage orange tree may be good for something, but the fruit, not so much. "The fruit of the Osage orange is a nuisance in the home landscape and has little value," the Extension website shared. A

Makeup artists in New York City (of course) liked the otherwise useless pomifera, and were willing to pay 85 bucks for a half ounce of the stuff. Ah, city folks.

Oh, squirrels seem to like the fruit, too. And I'm guessing they're not paying 85 bucks for a half-ounce snack. I wonder if hedge hogs like hedge apples. I wouldn't hedge a bet on that. Sorry.

to admire beauty of trees

Each season brings a different look to the garden, and some plants are uniquely beautiful in winter.

Rhonda Ferree, a horticulture educator with University of Illinois Extension, says that winter is a great time to see a plant's texture and form: each unique and mystical.

"Look for the differences between these trees this winter: oak, maple and red bud," says Ferree.

Oaks are the kings of the forest. They soar well above the maples and smaller redbuds. Oaks are majestic in size and texture.

The white and bur oak are most majestic. A white oak will grow well over 100 feet tall in the wild. It has a medium to a coarse texture in winter, but the widespreading branches exhibit a strong, bold appearance.

Bur oaks are a bit more coarse in texture and probably even more majestic with massive trunks and stout branches.

There are many other types of oaks too. A pin oak is much different from the white and bur. Although still medium to coarse textured in winter, a pin oak has a strongly pyramidal habit.

Rhonda says that her college classmates called this the 55-mile per hour tree because they could recognize it even at highway speeds.

Maples also come in many different shapes and sizes, from the dainty Amur maple to the sturdy sugar maple to the weak silver maple.

Sugar maples grow 60 to 75 feet tall with a rounded character. They are hard, sturdy trees. Their texture is medium in winter. Notice their beautiful bark, which with age becomes deeply furrowed, with long irregular thick plates or ridges.

Silver maples are very popular because they grow fast. Unfortunately, this is not always a good trait, Ferree said, since fast-growing trees are usually also weakwooded, often breaking in wind and ice.

The silver maples grow a bit more oval than rounded and are a bit coarser in the winter, often looking disheveled.

Amur maples and redbuds are similar in that they are both small, understory trees.

The Amur maple is a small tree or sometimes a multi-stemmed shrub, but is usually round shaped. It has very slender, fine branches and thus a medium-fine texture.

Red bud is a small tree with medium winter texture. Although best known for its spring flowers, it also has interesting bark in winter. Look for orange inner bark peeking through the outer black or brownish bark. somewhere wants just what you don't need anymore.
