The National Weather Service office in Paducah early this week issued a winter weather advisory for parts of Southern Illinois and Southeast Missouri.

The advisory went into effect at 6 p.m. Tuesday and continued through noon Wednesday.

Wet snow was expected in the areas under the winter weather advisory. Total snow accumulations of up to 2 inches were expected, along with winds gusting as high as 30 miles per hour.

"Plan on slippery road County in Missouri were conditions," the weather service advised. Hazardous conditions may have had an impact on the Wednesday morning commute.

Winter Storm Warning The weather service also issued a winter storm warning for parts of Southern Illinois and Southeast Mis-

among the counties under the winter storm warning. The warning was in effect from 6 p.m. Tuesday through noon Wednesday. The weather service ad-

vised that heavy, wet snow was expected in the areas under the winter storm warning.

Total snow accumulations of 4 to 6 inches were possible. The weather service noted that "sharp gradients of little snowfall to significant snowfall across a few miles" were possible.

Slippery road conditions and hazardous travel conditions were possible Wednesday morning.

"Winds will be rather strong and gusty. The combination of gusty winds and heavy wet snow could stress power lines," the weather service stated.

Assault weapons ban focus of legal action

SPRINGFIELD – IIlinois Attorney General Kwame Raoul on Monday filed a petition asking an appellate court to vacate a temporary restraining order that was issued late Friday afternoon, Jan. 20, blocking enforcement of the state's recently-passed assault weapons ban.

Raoul's office filed the petition in the 5th District Appellate Court in Southern Illinois, arguing that Effingham County Judge Josh Morrison had abused his discretion and the plaintiffs are unlikely to succeed in their lawsuit, thus the restraining order was granted incorrectly.

Morrison's late Friday order applies to only the 800-plus plaintiffs in the case filed by Tom DeVore, the unsuccessful 2022 GOP candidate for attorney general.

"Although disappointing, it is the initial result we've seen in many cases brought by plaintiffs whose goal is to advance ideology over public safety," Gov. JB Pritzker said in a statement shortly after the order was announced.

House Speaker Emanuel "Chris" Welch, D-Hillside, and Senate President Don Harmon, D-Oak Park, issued similar statements within hours of the judge's decision.

'We passed the Protect Illinois Communities Act to get dangerous weapons off the street and create a safer statement. "This ruling will be appealed. We look forward to our day in court to zealously advocate for our neighbors who are weary of the gun violence epidemic."

But the Illinois State Rifle Association, which has filed a separate challenge to the law in federal court, applauded Morrison's ruling, saying the ruling is "a clear indication" that Pritzker and lawmakers "rammed this law through improperly."

In his ruling Friday, Morrison sided with the plaintiffs' argument that there were legitimate issues about whether the law violates their rights to due process and equal protection because it limits most people's Second Amendment right to keep and bear certain firearms, while at the same time exempting some groups of people from the law but not others.

But Morrison also devoted much of the opinion to the procedural shortcuts lawmakers used to pass the bill - shortcuts routinely used in order to pass legislation quickly, especially when the General Assembly is facing statutory or constitutional deadlines.

In this case, the law's underlying bill, House Bill 5471, passed through both chambers in its final form during the final two days of the legislature's "lame duck" session earlier this month, with Pritzker signing the bill the night of Jan. 10. At noon the next day, Jan. 11, newly-elected lawmakers were sworn in began, meaning the process would have had to start over after that point.

A House committee held multiple hearings on the bill in December, but at that time the draft language of the bill was contained in HB5855.

The Illinois Constitution requires that bills be read by title into the record on three different days in each chamber, a process that would normally take at least five days to complete. But at the tail end of the lame duck session, lawmakers didn't have that much time, so engaged in a commonlyused maneuver known as "gut and replace."

That means the Senate took a bill that had already passed the House – in this case, one amending a portion of the state's Insurance Code dealing with public adjusters – gutted it of all its content and replaced that content with the language of the assault weapons ban. Then they sent the "amended" bill back to the House for an up-or-down concurrence vote.

"This Court finds that the Defendants unequivocally and egregiously violated the Three Readings Rule of the Illinois Constitution in order to circumvent the Constitutional requirements and avoid public discourse," Morrison wrote.

Morrison also said he believes the legislation violates the Constitution's requirement that bills be limited to only one subject, unless they deal with appropriations, codification, R. McCormick Foundation.

state," Harmon said in a and a new biennial session revision or rearrangement of laws. He said the assault weapon bill violates that provision because it contains provisions that also relate to human trafficking and drug trafficking.

The Illinois Supreme Court, however, has historically declined to strike down legislation based on either of those two arguments, ruling repeatedly that if the speaker of the House and president of the Senate both certify that a bill was properly passed, the court would not secondguess that decision.

Morrison was just elected as a 4th Circuit judge in November. Prior to that, he had been the state's attorney in Fayette County and was among a group of state's attorneys who sued the state to challenge the constitutionality of the sweeping criminal justice reform law passed in 2021 known as the SAFE-T Act.

In 2020, during the height of the COVID-19 pandemic, Morrison also wrote to Raoul to question the enforceability of Pritzker's emergency orders at the time. DeVore later cited that letter as part of his 2022 campaign for attorney general.

This came as the CDC reported on Friday that 28 Illinois counties were at an elevated community level for COVID-19, compared to 61 a week earlier.

The information was being provided to help residents know their county's transmission level and what they should do to reduce the spread of COVID-19.

"While it's been a few weeks since we had one of our counties at a high community level, we continue to see cases rise and fall in nearly every county," Southern 7 Health Department community outreach coordinator Shawnna Rhine said in a news release. "We're asking every-

one to protect themselves when traveling throughout the region...making sure they are up-to-date on their boosters if needed and to do their part to keep our most vulnerable safe.

COVID-19 and flu vaccines are available for adults and children 6 months and older by appointment only at each Southern 7 public health clinic. Southern 7 has a public health clinic in Anna.

Adults can also get their shots, without an appoint-

COVID continues into winter months

As cases of COVID-19 continue into the winter months, Southern 7 Health Department is encouraging Illinois residents to take advantage of preventative and treatment services available, including requesting free rapid tests to have on hand.

The Illinois Department of Public Health, IDPH, is helping residents of the state to prepare for a winter surge by offering 1 million free COVID-19 rapid antigen tests to Illinois residents in all Zip Codes, outside the City of Chicago, through a

partnership with the Rockefeller Foundation's public charity, RF Catalytic Capital and its Project ACT (Access COVID Tests) program.

A total of five, free rapid tests will be delivered to every household that requests them.

Households are eligible to request tests on a monthly basis while supplies last at https://www.accesscovidtests.org/.

Public health officials said that after performing a data analysis, there are still quite a few Zip Codes (just over 300) in Illinois where no households have requested free tests. This includes all Zip Codes in Hardin, Johnson, Massac, and Pulaski counties, Southern 7 Health Department reported.







- 7. Be more negative. Everybody knows that all kids are delinquents, all business people are crooks and all public officials are just looking out for themselves. Try to get in as many bad remarks about the town as possible.
- 8. Be skeptical, cynical and critical about anything designed for the community's progress and betterment and do it as loudly as possible. Blame progress for every difficulty, economic development for changing things from the way they were in the good old days, and disagree with anything that makes things different in your town.

Most people interact with 10 or more people every day of their lives. That's 310 individuals this month alone. Think of the good you could do by keeping a more positive attitude when talking about your community.

Tax filing season begins

The Internal Revenue tax return. Service, IRS, announced Monday, Jan. 23, as the beginning of the nation's 2023 tax season when the agency would begin accepting and processing 2022 tax year

The IRS announced in a news release on its website that more than 168 million individual tax returns are expected to be filed, with the vast majority of those coming before the April 18 tax deadline.

People have three extra days to file this year due to the calendar.

With the three previous tax seasons dramatically impacted by the pandemic, the IRS said it has taken additional steps for 2023 to improve service for tax-

As part of the August passage of the Inflation Reduction Act, the IRS has hired more than 5,000 new telephone assistors and added more in-person staff to help support taxpayers.

The IRS urges people to have all the information they need before they file a

Filing a complete and accurate tax return can avoid extensive processing and refund delays as well as avoid the possibility of needing to file an amended tax return.

In addition, the IRS encourages people to carefully review their tax situation to make sure they don't overlook important tax credits they may be eligible for, like the Earned Income Tax Credit, EITC.

The filing deadline to submit 2022 tax returns or an extension to file and pay tax owed is Tuesday, April 18, 2023, for most taxpayers.

By law, Washington, D.C., holidays impact tax deadlines for everyone in the same way as federal

The due date is April 18, instead of April 15, because of the weekend and the District of Columbia's Emancipation Day holiday, which falls on Monday, April 17.

Taxpayers requesting an extension will have until Monday, Oct. 16, 2023, to


Senior Hall of Fame seeks nominations



Mammoth bones...teeth from big ol' shark...

At least I don't need insulated chest waders, boats, diving apparatuses or remote-operated cameras to enjoy one of my favorite pastimes. Last weekend, I was doing a little bit of catching up by reading copies of USA TODAY which had shown up in our mailbox just across the street. The mailbox, by the way, needs some tender, loving care. It's leaning, just a bit...not as much as that famous tower in Italy, though.

A couple of stories piqued my interest. Both of the stories, strangely enough, were in the January 16 issue of the paper. And both were about fossils. As you probably know by now, yours truly likes fossils.

One of the stories reported that in New York City, 'Treasure hunters have taken to the East River after hearing a guest on Joe Rogan's podcast claim that potentially valuable prehistoric mammoth bones were dumped in the river in the 1940s." The treasure hunters were using all kinds of special equipment in their search.

The article noted that the American Museum of Natural History said in a statement that "We do not have any record of the disposal of these fossils in the East River...'

I haven't found any signs of mammoth bones while wandering around in Union County looking for fossils. Although, while crafting this week's gem of a column, I did find information online which shared that a mammoth was discovered in 1927 near Golconda during construction of a dam on the Ohio River. Did not know that.

I'm guessing there were folks who figured they could find the mammoth bones in the river in New York City and get rich. After all, there are fossils selling for millions of dollars these days. I'm guessing they would just get wet.

To be honest with you, I don't give much thought to the monetary value of the fossils I find. One time, I showed a fossil I had found to a fellow traveler on the Journey Through Life. He looked at the treasure and said: "Wow. That might be worth a lot of money."

Just for the sake of knowing such things, I paid a visit December 26 in Kansas City. to eBay and did a search for the kinds of fossils I bring home. When I am lucky enough to find them. My gems are worth a couple of bucks each. If somebody actually would be willing to pay for them. So much for that retire-

The other story was about a 9-year-old Maryland girl who was fortunate enough to make a "once-in-a-lifetime find." On Christmas morning, of all days. The fossil she discovered in the waters of Chesapeake Bay was a 5-inch tooth which belonged to a now extinct shark called a megalodon. The critter lived millions of years ago.

The young lady was quite surprised to find her very special Christmas gift. All I can say to her is "Good on you." I hope she finds another fossil shark tooth that is 6 or 7 inches long.

The story in USA TODAY shared that the 9-year-old, along with her sister, had asked for insulated chest waders as Christmas presents. They wanted to wear the chest waders to go hunting for shark teeth. Each of the girls did indeed recieve waders for Christmas...and it was off to the hunt that very day.

Just like mammoth bones, I have never found any shark teeth while on the hunt for paleontological treasures. However, the fossils I do find also are the remains of creatures which lived in our little corner of the world millions of years ago...when we were at the bottom of an ocean.

Generally, I will find fossils that resemble sea shells. Guess that's because they are (or were) sea shells, belonging to critters called brachiopods.

Ultimately, though, my "dream" fossil find would be a complete trilobite. Trilobites also were critters that lived in the oceans millions of years ago. They looked a little bit like the sow bugs we find in our yards. And, like the giant shark, trilobites are extinct. But they

left behind some very nice fossils. I've found a fair number of trilobite fossils. Just not that special one. I know its out there...just waiting to be discovered...

So, I'll keep looking. Most of the time, the search mostly will be about spending time outdoors...in the winter...spring...summer...fall.

Sometimes, after it's been raining a lot in Southern Illinois, and I'm heading for a creek bed or two, I'll put on my well-worn, comfortable, water-proof boots. But I'm thinking it may be time to get some insulated chest waders...

"This generation never knew peace, the next generation will know peace."

President Richard Nixon spoke these words as he announced to the American people that the end of the War in Vietnam is in sight.

President Nixon told the American people Tuesday night that an agreement had been initialed in Paris Tuesday, Jan. 23, and would be signed Saturday, Jan. 27, by Secretary of State Rogers, representing the United States and officials of the countries involved.

The United States is now without a living former President with the death of Lyndon Baines Johnson, 64, in Texas

The 36th President is the second former President to die in recent months. Harry S Truman, 33rd President, died

The county will be faced with a number of elections this spring beginning with the primary to be held March 20. The only position to be voted on in this election is for that of County Commissioner. Four are seeking the nomination for this post, two from each of the major parties.

Civil defense sirens sounded in the Union County area as funnel clouds were sighted within 20 miles of the county Thursday afternoon, January 18.
