# World Kidney Day activities planned in Anna

March 9 and the Illinois Public Health Association. IPHA, is hosting a community health fair at Shawnee Community College's extension center in Anna and at Union County Hospital in Anna.

Organizers of the event report that the event is scheduled to include:

Participation is free. There are no residency requirements. Health insurance will not be required.

Community health workers supported by IPHA are working with the National Kidney Foundation of Illinois to bring their World Illinois for the first time.

World Kidney Day is a day to celebrate kidney health and promote awareness of kidney disease across the globe.

IHPA notes that 37 million American adults are estimated to have chronic kidney disease, but they have reason to believe hundreds of thousands of Illinoisans are unaware of their condition.

# Storm system Friday brings heavy rain, strong winds

A strong storm system led to significant impacts across the region on Friday,

The National Weather Service office in Paducah reported that heavy rainfall amounts of 3 to 4.5 inches produced widespread flash flooding, along with numerous road closures.

Very strong winds occurred, ranging between 50 and 70 miles per hour. The winds were associated with both thunderstorms and gradient winds afterwards.

The line of storms moved through during the late morning and midday time period, and then very strong winds continued for hours afterwards through the af-

The weather service office issued a rare high wind warning to account for the strong winds that persisted for hours.

The magnitude and duration of this wind produced significant damage to trees, power lines, homes and other structures.

Soggy ground due to the excessive rainfall likely contributed to some trees being more susceptible to being blown over, the weather service reported.

Numerous power outages occurred, particularly across Western Kentucky.

A brief EF-2 tornado occurred just south of Paducah, Ky., shortly after 11 a.m.

Finally, the lowest barometic pressure of all-time was observed in Paducah (977.7 mb).

#### Winds

Some areas across western Kentucky observed their strongest winds along the line of storms that moved through between 10:30 a.m. and 1 p.m. Friday. These were generally in the 60 to 70 mph range.

Most areas tended to observe their strongest winds after the rain ended though.

7 Health Department plans smoking by age 26. to join local young people in observing Take Down Tobacco National Day of

The Day of Action is a nationwide movement organized by the Campaign for

Tobacco-Free Kids. The health department will help local young people advocate for more comprehensive smoke-free policies, including outdoor spaces and vaping, in their schools and communities.

On Take Down Tobacco Day, youth advocates across the country will rally together to stand up and speak out against the influence of the tobacco industry on kids.

According to the CDC, nearly nine out of 10 adults who smoke cigarettes daily first try smoking by age

On March 31, Southern 18, and 99 percent first try

Each day in the United States, about 1,600 young people smoke their first cigarette and nearly 200 youth start smoking every day.

Southern 7 Health Department shared that if cigarette smoking continues at the current rate among young people in the country, the CDC projects that 5.6 million of today's Americans younger than 18 will die early from a smokingrelated illness. That's about 1 of every 13 Americans aged 17 years or younger who are alive today.

Smoking by youth and young adults can cause serious and potentially deadly health issues immediately and into adulthood, the health department noted.

Local weather observer Dana Cross recorded a wind gust of 40 miles per hour at 1 p.m. Friday.

Many locations, including Paducah, recorded wind gusts in the 55 to 62 mph range anywhere from 20 minutes to three hours afterwards.

Highest winds were along and to the east of the surface low pressure track that moved from New Madrid, Mo., to Paducah and on to Evansville, Ind.

The extreme wind produced widespread power outages across Kentucky. At the peak of the event, over 500,000 customers were without power across the entire state.

#### Flooding

Flash flooding was widespread across the region, with numerous roads flooded/closed due to extremely heavy rainfall amounts.

Flash flood warnings were in effect for 53 of the 58 counties in the Paducah weather service office's

A surface low moved northeast from Texarkana, Ark., around 9 p.m. on

March 2 to Evansville, Ind.

It rapidly deepened as it moved from northeast Arkansas to New Madrid, Mo., and then up the Ohio River from Paducah to Evansville, Ind. By 6 p.m. on March 3 it was already located near Columbus, Ohio.

The pressure dropped 13mb from 989mb to 976mb over a seven-hour period.

The weather service reported this was very rare for the region to experience barometic pressure levels

In fact, both Paducah and Evansville, Ind., recorded their all-time lowest pressure on record.

For comparison this was roughly 10mb lower than what the pressure was when Hurricane Ike passed through the region back in

Pressure falls of 8 to 10 mb in two hours occurred during the afternoon as the low pressure system lifted to the northeast.

#### **Rain Reports**

Widespread rainfall totals of 3 to 4.5 inches occurred across the heart of the region. Rainfall totalled 2.09 inches in Jonesboro.

A small corridor of lower totals, ranging from 1 to 2.5 inches, occurred along the northern tier of Southern Illinois from Perry to Wabash counties and across the southern Pennyrile region of Western Kentucky.

Daily rainfall records were established at all five of the weather service office's official climate sta-

The daily total of 4.16 inches at Paducah on March 3 was the wettest calendar day in nine years, since 4.55 inches was observed on Aug. 30, 2014.

The highest two observed amounts were 5.20 inches from a trained spotter in eastern Pope County in Southern Illinois and 4.74 inches from a weather service employee in Lone Oak, Ky.

"COVID-19 community levels across the state remain stable again this week," IDPH director Dr. Sameer Vohra said in a news release on March 3.

"However, we are reporting four counties in Southern Illinois that are at a high community level for COVID-19.

"IDPH continues to monitor COVID-19 and other respiratory diseases closely throughout Illinois, with extra attention towards those most at-risk.

"Treatments continue to be effective, but timing is important. Seek treatment with your local healthcare provider or use the newly available test to treat service as soon as you develop symptoms."

## 🌣 "The Preaching Pen" What Would You Like Not to Lose? Everyone loses things sometimes; we lose money,




We must not lose our courage. Courage is the ability to accomplish tasks in the face of fear and doubt. In Joshua 1:3-9 God promised his people a blessing if they would be "daring" "according to the law," daring in mouth, mind, and actions. God's expectations did not change after the death of Moses. Joshua still followed and encouraged others Joshua 10:25; so should we. Our courage can inspire and stir up the courage of others. We must be thankful for the opportunities like Paul in Acts 28:15.



I met Alice Thodoropoulos from Metropolis when I was a P. M. at the DAR meeting held at the PAST House. Alice told about her son and daughter-in-law's tulips. Their u-pick tulip patch should be opening within the next three weeks or so.

When I was in 7th grade my parents Claude A. and Bessie Mae Corbitt Davis took me to see all the beautiful tulips in Holland, Mich. I still have my wooden shoes they bought me from there. I remember all the beautiful tulips and walking the path between

I was so excited to receive this information from Natalie Thodoropoulos and want to share with everyone that very close to us is another beautiful tulip patch where we can actually go pick our own tulips.

#### From Natalie Hi Mrs. Webb

After two seasons of growing tulips as cut flowers from their home in Paducah, Ky., Adrian and Natalie Thodoropoulos, owners of Tulip Lane, decided it was time to do more with a flower that has held such a special place in Natalie's heart over the years.

Her grandfather grew mass plantings in his front yard when she was young. Little did she know, 34 years later, how much of an impact those cheery little flowers would have on her life.

Retailing and wholesal-

ing tulips on a small scale has allowed Natalie to obtain a greater understanding of a flower that can be so fleeting in the spring.

After attending a workshop in Vermont in 2022, she learned the ins and outs of forcing tulips to bloom outside of their regular season. Thanks in no small part to this workshop and her existing knowledge, this year has been the first year she's been able to consistently grow tulips outside of

Valentine's Day this year was an incredibly special day for her, as she was able to have locally grown tulips in the middle of winter, when local flowers are

Natalie, along with other small growers across the U.S., are working hard to gain a foothold in a market that is dominated by imports. Close to 80 percent of the cut flowers sold in the U.S. are imported from places as far as Columbia, Ecuador, and The Netherlands. They are standard varieties without fragrance that have been shipped out of water over long distances.

In addition to retailing and wholesaling tulips this year, Adrian and Natalie will be hosting a u-pick tulip patch outside of Metropolis.

Last fall she and her husband, along with friends and family planted 30,000 tulips for people to enjoy this coming spring. "Planting that many tulips without equipment is rather comical," says Natalie, "but we managed to make it work". ## Farm bill critical to keeping America's food supply affordable

Farmers across the state are gearing up for another productive spring planting season.

Once the frost melts and the soil temperatures rise, it will be time to hit the fields, but for many farmers high prices for fertilizer, fuel and other critical tools remain a

Like consumers, farmers are feeling the pain of ongo-

The ripple effects of the war in Ukraine and supply chain issues pose significant hurdles for farmers.

Heading into the spring season and farm bill negotiations, these difficulties remain top of mind at Illinois Farm

In early February, the United States Department of Agriculture's latest Farm Sector Income Forecast report indicated that U.S. net farm income will fall nearly 16 percent from the previous year, while production costs are expected to increase more than 4 percent. That's on top of an already record increase in production costs in 2022.

While fuel and fertilizer prices are expected to soften, other costs related to marketing, storage and transportation are expected to increase 11 percent, and labor by 7 percent.

Rising interest rates and farm sector costs are another concern, as the USDA projects farm sector debt will increase \$31.9 billion to a record \$535 billion.

General inflation is a long-term issue squeezing the pocketbooks of families across America, but the farm income forecast is a reminder that farmers are not benefiting from higher prices at the grocery store.

While some commodity prices are rising, farmers are grappling with additional circumstances, such as drought, avian influenza and supply and labor costs.

After accounting for business expenses, farmers' share of the food dollar is only 7.4 cents.

That is why the farm bill is so important for everyone, not just farmers. Farm bill programs provide farmers with critical support to mitigate natural disasters and

Other programs secure America's domestic food supply, which keeps our agricultural economy strong while providing consumers with affordable, high-quality products at the grocery store.

The farm bill also addresses hunger through nutrition programs, which serve our most vulnerable populations and ensure that everyone has access to affordable, fresh and healthy food.

Conservation is another key focus of the farm bill, which invests in agriculture research and conservation programs to increase sustainability.

IFB is dedicated to working with our members and elected officials on both sides of the aisle to pass a farm

bill that meets the needs of all agriculture segments. Our members and leaders believe the farm bill must maintain the link between nutrition and commodity programs.

IFB also supports maintaining the current crop insurance program, providing price and revenue protection for farmers, and retaining both SNAP and TEFAP (The Emergency Food Assistance Program) in the farm bill in their current form.

As we head into another eventful spring, I look forward to working with our members and elected officials to get this critical piece of legislation to the president's desk.

# Deer hunters, meat processors, food pantries work together to fight hunger

takes a hit, including food pantries. But now, a local and widespread source of protein – venison – is making its way from the field onto plates providing 24,500 meals with the help of the University of Illinois Extension Deer Donation Program. One in 10 people in Illinois struggle with hunger every day, including one in eight children.

The 12-county pilot program aims to fight food insecurity by connecting hunters in East Central Illinois with meat processors and food pantries.

"Food prices are high, meat prices are high and pantries are really struggling with getting meat right now," says Michelle Fombelle, Extension SNAP-Ed educator. "This is an opportunity for hunters to help their communities while doing something they enjoy and supporting local small businesses."

Extension staff made their first venison delivery to a food pantry in November. Since then, hunters have donated at least 6,137 pounds of venison, providing more than 24,548 meals for Clay, Coles, Cumberland, DeWitt, Douglas, Effingham, Fayette, Jasper, Macon, Moultrie, Piatt and Shelby counties.

Those involved with the program say it is a win-win for everyone – the environment, local economies, and hungry individuals. Hunters with full freezers can harvest more deer and reduce the population size, preventing deervehicle accidents and damage to natural areas and crops.

Meat processors get more business and are reimbursed through funds provided by donations and grants. And food pantries can share protein with those in need.

Fombelle and other Extension staff have been exploring a deer donation program since 2016. Many surrounding states have had similar programs

for years, and Fombelle reached out to understand their process and the challenges they face, such as limited processor capacity and fewer hunters.

"The timing ended up being perfect for this project," Fombelle said. "We see food insecurity all the time in our communities, but after the height of the pandemic, we all

saw the food crisis with increased prices and shortages." None of it would be possible without local meat processors. The six initial processors for the pilot program

URBANA – When food prices are high, everyone stored and cured the donated whole deer during the busy hunting season before butchering it into 1- to 2-pound frozen packages of ground venison. Each deer provides about 60 pounds of meat, and processors are reimbursed

> \$100 per deer. Extension staff deliver the finished product to pantries where SNAP-Ed staff provide samples, cooking tips, nutritional information and recipes.

"I had no experience working with venison or wild game, and there are pantry clients in the same situation," says Extension nutrition and wellness educator Caitlin Mellendorf.

However, an encouraging 84 percent of pantry clients surveyed early in the process said they would feed venison to their family.

Mellendorf says that to get people more comfortable with venison, they did a lot of recipe testing. "We found out venison chili might be the go-to for a lot of people, but what are the other things that we can do?" Some of the favorites so far have been shepherd's pie, tacos and a classic Midwestern comfort food: Tater Tot casserole.

The deer donation program has received support from food pantries, hunting organizations such as Whitetails Unlimited Illinois, and the Illinois Association of Meat Processors.

The program is funded by grants, donations, and the Health Equity Achieved Together project, a multidisciplinary collaboration with University of Illinois Supplemental Nutrition Assistance Program Education.

In November, the Lumpkin Family Foundation provided a \$25,000 grant to reimburse meat processors. Extension staff have raised at least \$34,600, which will cover the cost of processing 346 deer and provide an estimated 83,040 meals.

With such positive feedback in their first year, Mellendorf and Fombelle are now looking for ways to expand the program to more counties and find consistent funding moving forward.

"I would also love for deer donation to become a common practice," Fombelle said. "And to one day have hunters go out and harvest a deer specifically to feed their community."
